as Document No. 748162 , quitclaiming to AVCO COMMUNITY DEVELOPERS, INC., a corporation, existing easements for open space purposes affecting portions of Lots 7 and 8, Oaks North Unit No. 2, as more particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to deliver said deed to the Property Director of said City for further handling.
