

RESOLUTION No. 211217


Adopted on AUG 1 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$99,000 from Community Buildings and Improvements Bond Fund 726 of The City of San Diego is hereby authorized solely and exclusively for the purpose of improving the capability and increasing the capacity of the Fire Communications Center operations.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and empowered to do by City Forces miscellaneous improvements in conjunction with the above referenced project, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract, at an estimated cost of \$8,000.
