
WHEREAS, A.B. 3638 is scheduled to be heard in the Senate Education Committee on August 7, 1974; and

WHEREAS, A.B. 3638 is intended to (a) clarify anomalies and inconsistencies of present public school facilities lease and lease/purchase law, and (b) simplify and unify the present statutory approach to the lease and lease/purchase of all public school facilities; and
