
RESOLUTION No. 211234

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$18,143.00 by Wilcox Electric Inc. dba Arrow Electric, a corporation, for MODIFICATION OF TRAFFIC SIGNAL SYSTEM ON GARNET AVENUE AT INGRAHAM STREET; CONSTRUCTION OF TRAFFIC SIGNAL INTERCONNECTION ON GARNET AVENUE BETWEEN INGRAHAM STREET AND JEWELL STREET; AND REPLACEMENT OF TRAFFIC SIGNAL CONTROLLER ON GARNET AVENUE AT MISSION BAY DRIVE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 747413.
2. That the expenditure of \$24,600.00 is hereby authorized out of Gas Tax Funds (Fund No. 220) and that the expenditure of \$2,000.00 is hereby authorized out of Capital Outlay Funds (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for MODIFICATION OF TRAFFIC SIGNAL SYSTEM ON GARNET AVENUE AT INGRAHAM STREET; CONSTRUCTION OF TRAFFIC SIGNAL INTERCONNECTION ON GARNET AVENUE BETWEEN INGRAHAM STREET AND JEWELL STREET; AND REPLACEMENT OF TRAFFIC SIGNAL CONTROLLER ON GARNET AVENUE AT MISSION BAY DRIVE in the City of San Diego, and related costs.
