- 1. That that certain real property described in that form of quitclaim deed on file in the office of the City Clerk as Document No. 748212 , be, and the same is hereby authorized to be sold by negotiation for the sum of eighty-five dollars (\$85) to ROYAL PROPERTIES, INC., a Nevada corporation.
- 2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document

  No. 748212 , quitclaiming to ROYAL PROPERTIES, INC., a Nevada corporation, easements for drain purposes across portions of Lots 429 and 488, Fashion Heights Unit No. 3, as more particularly described in said form of quitclaim deed.
- 3. That no broker's commission shall be paid by City on the herein-described negotiated sale.
- 4. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
