

That the acceptance by the City Manager of that deed of MIDWAY DRIVE-IN THEATRE CORPORATION, executed in favor of The City of San Diego, bearing date of June 13, 1974, conveying to said City an easement and right of way for a public street and incidents thereto across a portion of the East Half of Lot 3 in the Southeast Quarter of the Southwest Quarter of Section 10, Township 15 South, Range 3 West, S.B.B.M., according to United States Government Survey approved February 19, 1883, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named MIRAMAR ROAD.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
