WHEREAS, the Southern California Gas Company, sole supplier of natural gas to San Diego Gas & Electric Company, has filed a gas rate increase application with the California Public Utilities Commission designated Application No. 53797; and

WHEREAS, Southern California Edison Company has made a motion in said rate increase application asking for what is alleged to be parity of service between steam electric generating customers in the Southern California Gas Company's system; and

WHEREAS, the practical effect of Southern California Edison Company's proposal is to divert some 10.2 billion cubic feet of gas from San Diego Gas & Electric Company to steam generating plants in the Los Angeles area; and


WHEREAS, said diversion of gas is both economically and environmentally damaging to the City of San Diego; and

WHEREAS, the City Attorney's office has from the beginning of the rate increase application been attempting to protect the interests of San Diego by actively opposing the proposal by Southern California Edison Company to create parity; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Attorney continue to oppose the proposal by Southern California Edison Company before the California Public Utilities Commission for parity between steam electric generating plants in the Southern California Gas Company's service area, and to incur all necessary expenses in connection therewith.
