That the acceptance by the City Manager of that deed of W. R. GRACE LAND CORPORATION, a corporation, executed in favor of The City of San Diego, bearing date of June 17, 1974, conveying to said City an easement and right of way for a public street and an earth excavation or embankment, slope or slopes and incidents thereto across portions of Lots 1 through 11 of Sunshine Gardens, according to Map thereof No. 1804 filed August 27, 1924 in the office of the San Diego County Recorder, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named IMPERIAL AVENUE; and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street and the same is hereby named 47TH STREET.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
