
RESOLUTION No. 211317

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$59,786.88 by T.B. Penick & Sons, Inc., a corporation, for MODEL CITIES - AREA III-2, IMPROVEMENT OF LOGAN AVENUE BETWEEN 32ND AND 33RD STREETS; MCLAREN'S LANE, BETWEEN BANCROFT STREET AND 33RD STREET; AND HEMLOCK STREET AT 36TH STREET in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 747414.
2. That the expenditure of \$62,000.00 is hereby authorized out of Model Cities Third Action Year Streets and Alleys Program (Fund No. 2552) of the City of San Diego solely and exclusively for the purpose of providing funds for MODEL CITIES - AREA III-2, IMPROVEMENT OF LOGAN AVENUE BETWEEN 32ND AND 33RD STREETS; MCLAREN'S LANE, BETWEEN BANCROFT STREET AND 33RD STREET; AND HEMLOCK STREET AT 36TH STREET in the City of San Diego, and related costs.
