

RESOLUTION NO. 211359 **AUG 28 1974**

WHEREAS, the Council of The City of San Diego, by Resolution No. 208152 dated June 14, 1973, authorized the City Attorney to incur all necessary expenses in connection with participation on behalf of The City of San Diego in those certain hearings held before the California Public Utilities Commission and Federal Power Commission in the matter of gas and electric rate increase applications by Pacific Lighting Service Corporation, Southern California Gas Company and San Diego Gas & Electric Company; and

WHEREAS, funds were authorized by the Council and set aside at that time in the Allocated Reserve for such purpose; and

WHEREAS, the funds allocated in said previous authorization have been exhausted in representing the City before the above mentioned Commissions and it is necessary and desirable to augment said authorization to continue such active representation on behalf of the City; and

WHEREAS, the utility companies have continued to submit various applications for rate increases which will have a substantial impact upon the City of San Diego and its citizen rate payers; and

WHEREAS, the Council on August 8, 1974 by Resolution No. 211280 authorized the City Attorney to continue opposing

the proposal by Southern California Edison Company before the California Public Utilities Commission for parity between steam electric generating plants in the Southern California Gas Company's service area, and to incur all necessary expenses in connection therewith; and


WHEREAS, the City is still actively participating before the California Public Utilities Commission in Case Numbers 9581 and 9642 and will continue to actively protect the economic rights and interests of its citizens; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Auditor and Comptroller be and he is hereby authorized to transfer within the 100 Fund the sum of seven thousand five hundred dollars (\$7,500) from the Unallocated Reserve (53.30) to the Allocated Reserve (53.20) for the purpose of supplementing Resolution No. 208152 relating to expenses incurred in participating in California Public Utility Commission and Federal Power Commission rate hearings.
