WHEREAS, the residents of the Barrio Logan-Harbor 101 community, being that area of San Diego bounded on the east by Interstate 5, on the west by the waterfront, on the north by Commercial Street and on the south by the City limits, desire this area to be included in a recognized community plan; and

WHEREAS, there presently exists within this described area a resident/property owner general membership with an elected 15-member executive board representing a cross-section of the civic, social, business and neighborhood organizations, and tenant, resident and non-resident property owner, commercial and industrial ownerships, thus meeting the representation requirements of Council Policy 600-5; and

WHEREAS, the Barrio Logan-Harbor 101 Community Planning Association has requested formal recognition as the Barrio Logan-Harbor 101 Planning Group and does also request the services of the Planning Department in the development of a community plan for the Barrio Logan-Harbor 101 area; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The Barrio Logan-Harbor 101 Community Planning Association be, and is hereby authorized to represent the Barrio Logan-Harbor 101 community and to work with the City Manager's office and the Planning Department in the development of a long-range community plan consistent with community goals and objectives, and be

responsible for its presentation as well as the coordination of community support for its adoption and effectuation.

2. The Planning Department is directed to provide the requested assistance in developing a community plan for the Barrio Logan-Harbor 101 community.
