WHEREAS, Article VIII of said Memorandum of Understanding provided that the parties thereto further agreed to submit to the City Council for approval a separate noneconomic Memorandum of Understanding agreed upon by the Management Team and representatives of Local 127; and

WHEREAS, the noneconomic Memorandum of Understanding has now been reduced to writing and the parties desire the endorsement and approval of the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Council of The City of San Diego hereby endorses and approves the noneconomic Memorandum of Understanding agreed to by the Management Team and representatives of Local 127, AFSCME pertaining to the Maintenance and Labor Unit, and the Skilled Trades and Equipment Operator Unit pursuant to the provisions of the ██████████ Memorandum of Understanding on file in the office of the City Clerk as Document No. 748412.
