BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$5,478,000.00 by Gentry-Rados, a joint venture, for CONSTRUCTION OF SEDIMENTATION BASINS 5 AND 6 POINT LOMA WASTEWATER TREATMENT PLANT in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 747309.
2. That the expenditure of \$6,178,240.00 is hereby authorized out of Sewer Revenue Fund (Fund No. 506) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF SEDIMENTATION BASINS 5 AND 6 POINT LOMA WASTEWATER TREATMENT PLANT in the City of San Diego, and related costs.
3. That the City Auditor is hereby authorized to transfer \$2,058,240.00 within the Sewer Revenue Fund (Fund No. 506) from the Continuing Appropriation to Water Quality Program II Construction Outlay element (62.19-3495) for this purpose.
