RESOLUTION NO. 211415 **AUG 29 1974**

WHEREAS, since the early 1920's many of the City's residents who are of Chinese descent have used a special area of Mt. Hope Cemetery as a burial site; and

WHEREAS, The City of San Diego desires to landscape this area and make it available for additional burials for the public in general; and

WHEREAS, the Chinese Consolidated Benevolent Association desires to acquire the right to purchase for resale up to 200 of these lots for use of their Association members and others of the Chinese community; and

WHEREAS, the Council of The City of San Diego has set a schedule of fees for facilities and services of Mt. Hope Cemetery by Resolution No. 210193, adopted March 21, 1974; and

WHEREAS, the savings to the City in processing costs and other benefits accruing from a group involvement justifies a discount price of \$140 per lot which is \$25 below the price of the adjacent area; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized to sell to the Chinese Consolidated Benevolent Association not more than 200 Mt. Hope Cemetery burial lots within an area designated by City for

the sum of \$140 per lot, said purchase to be consummated within a five year period from date of this resolution with a minimum purchase of 40 lots per year with a condition that any lots not purchased within a specific year shall be deducted from the total allocation of said 200 lots.
