WHEREAS, Bill's Cab Company of Solana Beach has applied to the City Council for two Limited Certificates of Public Convenience and Necessity to operate automobiles for hire within the limits of the City of San Diego; and

WHEREAS, pursuant to Section 72.01 of the San Diego Municipal Code, the City Manager has caused an investigation to be made and has filed his written report with this Council; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That having filed an application for two Limited Certificates of Public Convenience and Necessity to operate taxicabs pursuant to the provisions of Section 72.01 of the San Diego Municipal Code, and the City Manager having conducted the required investigation, the City Council hereby grants two Limited Certificates of Public Convenience and Necessity limited to a six-month period and the pick-up areas of the Del Mar Heights/Terrace areas as indicated on the attached map to Bill's Cab Company to operate the vehicles specified in the application.

That the following rates to be charged by Bill's Cab Company have been found to be just and reasonable:

- (a) Flag Drop Rate - 60¢ for the first 1/5 mile,
- (b) 10¢ for each additional 1/5 mile following the first 1/5 charged against the flag drop, and
- (c) \$6.00 per hour waiting time.
