That the City Manager be, and he is hereby authorized and empowered, for and on behalf of said City, to execute an agreement with the COUNTY OF SAN DIEGO to continue the Model Cities Child Care Project from July 1, 1974 through December 31, 1974, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 748481.

BE IT FURTHER RESOLVED, that the expenditure of \$70,000, \$22,000 of which was previously authorized by Resolution No. 210857 for the months of July and August, 1974, is hereby authorized out of Model Cities Fund 2904 of The City of San Diego, solely and exclusively, for the purpose of providing funds for the operation of the above-mentioned project.
