

RESOLUTION NO. 211451 **AUG 29 1974**

WHEREAS, the Federal Aid Highway Act of 1973 provides for federal participation in the funding of both highway projects and transit projects under the Federal Aid Urban Program; and

WHEREAS, State guidelines have established the County of San Diego as lead agency in developing a cooperative process and program for the distribution of Federal Aid Urban funds; and

WHEREAS, the San Diego County Board of Supervisors, on February 13, 1974, in adopting a set of procedures for the Federal Aid Urban Program, established the City-County Thoroughfare Advisory Committee as the body responsible for recommending a program for distribution of Federal Aid Urban Funds; and

WHEREAS, said City-County Thoroughfare Advisory Committee has now prepared a recommended program for distribution of Federal Aid Urban funds for the three fiscal years ending June 30, 1976; and

WHEREAS, it is the policy of the San Diego County Board of Supervisors that said recommended program be submitted to the cities for review and comment prior to consideration by said Board of Supervisors; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That the City Manager be and he is hereby authorized to
notify the San Diego County Board of Supervisors that the
Federal Aid Urban Program for the three fiscal years ending
June 30, 1976, as recommended by the City-County Thoroughfare
Advisory Committee, is acceptable to The City of San Diego; a
copy of said recommended program being on file in the office
of the City Clerk as Document No. 748492.
