

RESOLUTION NO. 211452

AUG 29 1974

WHEREAS, the Federal Government has authorized and funded a Federal Aid Urban (FAU) program which provides funding assistance for street and transit improvements on a network of routes within urban areas; and

WHEREAS, before Federal aid will be made available for a local FAU program, local agencies and the State of California are required to enter into an agreement with respect to the area-wide program and with respect to the construction and maintenance of such improvement projects as may be financed in part with Federal FAU funds; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a master agreement with the State of California, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 748494.

2. That the City Manager be and he is hereby authorized and empowered, subject to the direction provided by the Progress Guide and General Plan for The City of San Diego as adopted by the City Council, and by generalized FAU programs approved by the City Council, to make all applications, studies and reports

and to provide certifications and information as may be required to obtain for City the Federal aid funds available under the FAU program. Such actions include, but are not necessarily limited to, the following:

a. Preparing and submitting the individual project applications together with such supporting information as is required.

b. Certifying and providing any requested evidence prior to advertising a project for construction that necessary rights-of-way are or will be available, that environmental procedures have been complied with, and that appropriate clearances have been obtained from other agencies.
