APPROVING MAP OF JOLY-SAPHIR SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by W. D. HARGUS, a Licensed Land Surveyor, entitled "JOLY-SAPHIR SUBDIVISION Being a subdivision of portions of Lots 1 through 8, inclusive, in Block 12 of Grantville and Outlots, according to the Junipero Land and Water Company's Amended Map No. 1, filed in the office of County Recorder of San Diego County, February 16, 1894, Map Number 776, together with the Alley as closed and vacated to public use, all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Friars Road and the Alley for public purposes, and said portion of street and the Alley are hereby declared to be portion of a public street and a public Alley and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of a public street and the public Alley are accepted on behalf of the

public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
