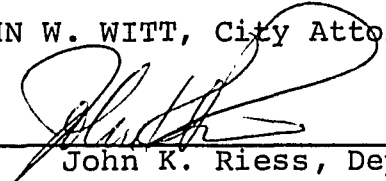
RESOLUTION No. 211496
