That the bid of \$94,814.10 by Daley Corporation, a corporation, for MODEL CITIES - AREA VI - 3, IMPROVEMENT OF SUNSET LANE, BETWEEN AVERIL ROAD AND SAN YSIDRO BOULEVARD; SYCAMORE ROAD, SOUTH OF BOLTON HALL ROAD; AND SELLSWAY STREET, EAST OF COTTONWOOD ROAD, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 747532.
2. That the expenditure of \$101,000.00 is hereby authorized out of the Model Cities Third Action Year Streets and Alleys Program (Fund 2552) of the City of San Diego solely and exclusively for the purpose of providing funds for MODEL CITIES - AREA VI - 3, IMPROVEMENT OF SUNSET LANE, BETWEEN AVERIL ROAD AND SAN YSIDRO BOULEVARD; SYCAMORE ROAD, SOUTH OF BOLTON HALL ROAD; AND SELLSWAY STREET, EAST OF COTTONWOOD ROAD, in the City of San Diego, and related costs.
