BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Dorman's, Inc. 2. Daniels Tire Service 3. Kennedy's Firestone are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of TIRES AND TUBES FOR TRUCKS AND PASSENGER CARS, as may be required for a period of one year beginning August 1, 1974 through July 31, 1975, per prices and escalation on file in the Purchasing Department, as follows:

1. Dorman's, Inc. for Groups I, III and VI; terms net 30 days plus sales tax; with option to renew contract for an additional year.
2. Daniels Tire Service for Group II; terms net 30 days plus sales tax.
3. Kennedy's Firestone for Groups IV and V; terms 2% 30 days plus sales tax; with option to renew contract for an additional year.
