APPROVING MAP OF CAMINO SOUTH SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


Said Council hereby finds that that certain map surveyed by DON NASLAND, a Licensed Land Surveyor, entitled "CAMINO SOUTH SUBDIVISION Being a subdivision of a portion of Lot 46 of the Partition of Rancho Mission of San Diego according to Partition Map thereof on file in the office of the County Clerk of San Diego County, Court Action No.348 entitled Juan M. Luco et al., vs. The Commercial Bank of San Diego et al., and a portion of Villa Lot 89 of Normal Heights, according to Map thereof No. 985, filed in the office of the County Recorder of said San Diego County, in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby accepted and approved.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of drainage, and the easement for open space over, under, upon and across a portion of Lot 1, all as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, and that said easement with the right of ingress and egress for the construction and maintenance of drainage facilities, and the open space easement, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
