
Adopted on SEP 12 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of the SAN DIEGO UNIFIED SCHOOL DISTRICT OF SAN DIEGO COUNTY, CALIFORNIA, executed in favor of The City of San Diego, bearing date of July 2, 1974, conveying to said City an easement for public street or highway purposes over and upon a portion of Lot 1, Block 63, and a portion of Lot 24, Block 62 of Arnold and Choates Addition, together with that portion of Ingalls Street dedicated on said Map, but vacated by Resolution No. 9206 adopted September 11, 1911 by the Common Council of the City of San Diego, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named WASHINGTON PLACE.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
