
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the SAN DIEGO STATE UNIVERSITY FOUNDATION, a nonprofit California corporation, to sponsor and fund an Institute on World Affairs which will provide a free academic forum through which the views of a wide variety of experts and public figures will be made available to the public and publicize San Diego as a center of intellectual activity, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 748644.

That the expenditure of \$5,000.00 from Transient Occupancy Tax Fund 224 is hereby approved solely and exclusively to provide funds for the services stated above.
