

RESOLUTION No. 211531

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 22507 of the California Vehicle Code and Section 86.05 of the San Diego Municipal Code, a tow-away zone is hereby established on and along the following street in said City:

80 feet in length on the northerly side of
COAST BOULEVARD in front on the La Jolla Cove
lifeguard station 575 feet east of Girard Avenue.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same are hereby authorized and directed to be made on said street, and that the regulations hereinabove imposed shall become effective upon the installation of such signs.
