

RESOLUTION NO. 211532

WHEREAS, there are various public streets more particularly described and shown on Drawing No. 16290-D on file in the office of the City Clerk as Document No. 748647 within the City of San Diego which are variously known and named, some officially, others unofficially; and

WHEREAS, said various descriptions and names have caused confusion and are generally misleading; and

WHEREAS, it appears to be in the public interest to officially establish and change the names of the above referenced streets; and

WHEREAS, the Planning Commission of The City of San Diego has recommended approval of said name changes and designations; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Cypress Street southerly of Interstate 5, and Sycamore Road northerly of Interstate 5 be and the same are hereby officially renamed VIA DE SAN YSIDRO;

That IRIS AVENUE be and the same is hereby designated as the official name of the street now known as both Iris Street and Iris Avenue between Beyer Boulevard and 27th Street, and for the overcrossing and unnamed street between 27th Street and State Highway 75;

That BORDER VILLAGE ROAD be and the same is hereby designated as the official name of the street constructed by the State of California between San Ysidro Boulevard and National Avenue, and for National Avenue between Bolton Hall Road and Border Village Road named by this resolution;

All as more particularly shown and described in Drawing No. 16290-D on file in the office of the City Clerk as Document No. 748647 which shall govern as to all details therein.

BE IT FURTHER RESOLVED, that the City Clerk of said City be and he is hereby directed to file a certified copy of this resolution in the offices of the County Clerk, County Recorder and County Surveyor of San Diego County.
