
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the SAN DIEGO CONVENTION AND VISITORS' BUREAU, a nonprofit California corporation, to encourage and promote tourism, trade and commerce in the City of San Diego by publicizing events, projects and programs in San Diego primarily through contacts with major airlines and travel organizations in other cities in the United States, Canada and Mexico, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 748642.

That the expenditure of \$40,000 from Transient Occupancy Tax Fund 223 is hereby approved solely and exclusively to provide funds for the services stated above.
