

Nachant, Inc., a corporation, for CONSTRUCTION OF VEHICLE FUEL FACILITIES FOR UNLEADED GAS - CENTRAL POLICE STATION in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 747753.
