

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of LURA L. DAVIS and CROCKER NATIONAL BANK, as Co-Executors of the Estate of John L. Davis, deceased, and LURA L. DAVIS, a widow, executed in favor of The City of San Diego, bearing date of July 29, 1974, conveying to said City an easement and right-of-way for a public street and incidents thereto, together with the permanent easement and right-of-way for a storm drain or drains affecting a portion of the West Half of Lot 3 in the Southeast Quarter of the Southwest Quarter of Section 10, Township 15 South, Range 3 West, S.B.B.M., as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcels 1 and 2 are hereby dedicated as and for a public street and the same is hereby named MIRAMAR ROAD.

BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, to the Property Director of said City for further handling.
