A RESOLUTION ESTABLISHING AN UNDERGROUND
UTILITY DISTRICT TO BE KNOWN AND DENOMINATED
AS THE IMPERIAL AVENUE, 46TH STREET TO ESCUELA
STREET, UNDERGROUND UTILITY DISTRICT.

WHEREAS, by Resolution No. 211347, a public
hearing was called for on SEP 19 1974 at the
hour of 8:30 a.m. in the Council Chambers of the City Administra-
tion Building, 202 C Street, San Diego, California, to determine
whether the public health, safety or general welfare requires
the removal of poles, overhead wires and associated overhead
structures and the underground installation of wires and facilities
for supplying electric, communication, community antenna television
or similar or associated service within that certain area of the
City of San Diego more particularly described as follows:

The following lots of SUNSHINE GARDENS, MAP 1804: the
southerly 50 feet of Lots 1 through 11; the following
lots and block of ALTA VISTA SUBURB, MAP 1029: Lots 1
and 2 of Block M; the following lots of LEMON GARDEN ACRES,
MAP 1390: the remaining portions of Lots 57, 58 and 59 from
highway opening 11-SD-805; the following lots and block of
HOMEDALE, MAP 1358: the remaining portion of the northerly
50 feet of Lot 1, Block 4 from highway opening 11-SD-805.

Said district shall include the following public right-of-way:

IMPERIAL AVENUE between the easterly right-of-way of Escuela
Street and the westerly right-of-way line of Interstate 805;
ESCUELA STREET between Imperial Avenue and 50 feet north of
Imperial Avenue; 47TH STREET between the southerly line of
Lot 2, Alta Vista Suburb, Map 1029 and the northerly line
of Lot 1, Sunshine Gardens, Map 1804; the ALLEY in Alta Vista
Suburb, Map 1029, Blocks M and N between the southerly line
of Lot 2, Block M and Imperial Avenue.

and all as more particularly shown on Drawing No. 16206-D, entitled "IMPERIAL AVENUE, 46TH STREET TO ESCUELA STREET, UNDERGROUND UTILITY DISTRICT," copies of which are on file in the office of the City Clerk as Document No. 748392 and attached hereto and incorporated herein as Exhibit A; and

WHEREAS, notice of such hearing has been given by the City Clerk to all affected property owners as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code, and the utilities concerned in the manner and for the time required by law; and

WHEREAS, such hearing has been duly and regularly held and all persons interested have been given an opportunity to be heard; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The City Council does hereby find and determine that the public health, safety and general welfare require the removal of poles, overhead wires and associated overhead structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service within the area set forth above and that pursuant to Chapter VI, Article 1, Division 5 of the San Diego Municipal Code, the above-described area is hereby declared to be an underground utility district in the City of San Diego, and the maps and document referred to above are hereby incorporated as a part of this resolution.


2. The City Council shall by subsequent resolution fix the date upon which the property in the district must be ready to receive underground service, and shall by subsequent resolution order the removal of all poles, overhead wires and associated overhead structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service.

3. The City Clerk be and he is hereby instructed to notify all affected persons as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code, and all affected utility companies of the adoption of this resolution within fifteen (15) days after the date of such adoption. The City Clerk shall further notify said affected persons as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code of the necessity that if they desire to continue to receive electric, communication, community antenna television or similar or associated service, they shall provide at their own expense all necessary facility changes on their premises so as to receive underground service from the lines relocated underground of the supplying utility company subject to applicable rules, regulations and tariffs of the respective utility company on file with the Public Utilities Commission of the State of California (as of the date of adoption of this resolution) and subject to all other applicable requirements of State law and City ordinances. The Clerk's notification shall be made in the manner provided in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code.

4. The City Council hereby finds that the underground utility district created herein is required by the public health, safety and general welfare for the following reason:

This street is extensively used by the general public and carries a heavy volume of pedestrian and vehicular traffic.

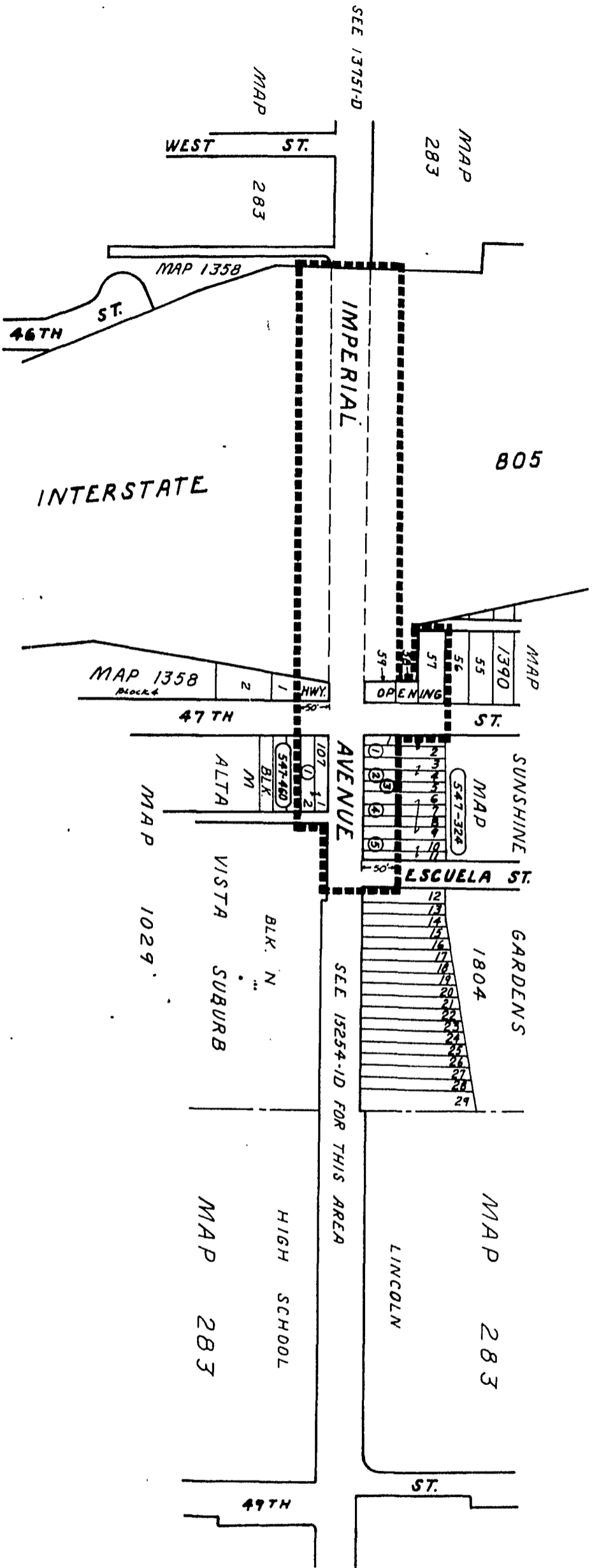
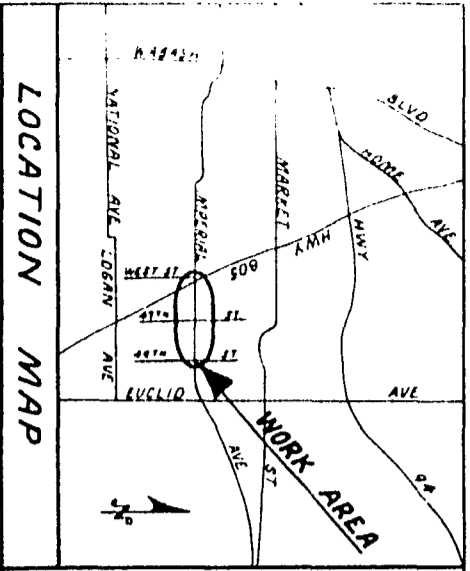
