WHEREAS, the band is scheduled to perform at the Calgary Stampede of 1975 in Calgary, Canada; and

WHEREAS, the internationally famous Calgary Stampede for 1975 will be held on the Fourth of July weekend in Calgary, Province of Alberta, Canada; and


