BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of JAMES CURTIS and MELVA CURTIS, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of July 19, 1974, conveying to said City an easement and right of way for a public street and incidents thereto, affecting a portion of Lot 19 of Caruthers Addition, according to Map thereof No. 27, filed in the office of the County Recorder of San Diego County, October 1, 1880, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named SAN PASQUAL STREET.

BE IT FURTHER RESOLVED, that the expenditure of \$2,800.00 from Gas Tax Fund 219 is hereby authorized solely and exclusively to provide funds for street acquisitions required for the Educational/Cultural Complex, including the above described easement.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, to the Property Director of said City for further handling.
