Charles T. Mc Afee	GENERAL SERVICES Street Division	\$75	Mr. Mc Afee, Senior Supervisor in the Street Division, became concerned with the amount of maintenance on street sweeper shoes (a guide on the surface of the street). He suggested a way to reinforce the shoes to reduce the amount of maintenance required. This was tried by the Equipment Division and it is estimated there will be a net saving of \$766 per year in maintenance.
Anita L. Belew	POLICE DEPARTMENT	\$75	Ms. Belew is a Parking Controller. She proposed a change in the parking citation form to provide the code number for the most common violation to be checked. This saves writing it 91,822 times a year. It is estimated this will save \$761 worth of time per year.
