BE IT RESOLVED, by the Council of The City of San Diego as follows:


That the bid of \$49,997 by Shamrock Electric Co., a corporation, for DATA PROCESSING CENTER AIR CONDITIONING AND ELECTRICAL ADDITIONS in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 748227; and

BE IT FURTHER RESOLVED, that the expenditure of \$61,000 is hereby authorized out of Capital Outlay Fund (Fund No. 245) of The City of San Diego solely and exclusively for the purpose of providing funds for DATA PROCESSING CENTER AIR CONDITIONING AND ELECTRICAL ADDITIONS in the City of San Diego, and related costs.

BE IT FURTHER RESOLVED, that the request of September 12, 1974 for a change order extending the completion dates provided in the aforementioned contract be and the same is hereby rejected and Shamrock Electric Co. shall be required to complete the contract work under the bonus-penalty provisions described in the contract in the time specified.
