BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized, for and on behalf of said City, to implement the concepts and strategies included in the Management Planning Program for the priority setting, administration and delivery of human care services. More specifically, that he is directed to:


1. Adopt the use of a standardized social planning process for all City departments and programs involved in the expenditure of funds for the provision of social services.

2. Adopt the use of standardized monitoring procedures for all City departments involved in the expenditure of funds for the provision of social services.

3. Adopt the use of specific tools and processes that have been developed or refined by the Management Planning Program to assist departments and programs in social planning efforts wherever possible.

4. Investigate the establishment of a County-wide social planning support unit as a joint effort between the City and County of San Diego.
