That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the STATE OF CALIFORNIA for installation of separate safety lighting conduit in conjunction with the installation of traffic signals and safety lighting on Mira Mesa Boulevard and Poway Road-Penasquitos Boulevard, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 748821.

BE IT FURTHER RESOLVED, that the expenditure of \$8,800 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for the City's estimated construction costs for installation of said conduit.
