
Adopted on OCT 3 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the Mayor and City Manager be and they are hereby authorized and empowered to execute for and on behalf of said City, a Second Amendment to Joint Powers Agreement with the Comprehensive Planning Organization to provide that the County shall have a weighted voting power of 40 and The City of San Diego a weighted voting power of 30 in connection with 31 specific A-95 projects as approved in principle by Resolution No. 211094, adopted on July 11, 1974, under the terms and conditions set forth in the form of Second Amendment to Agreement on file in the office of the City Clerk as Document No. 749048.

BE IT FURTHER RESOLVED, that Resolution No. 211456, adopted on August 29, 1974, be and it is hereby rescinded.
