That the City Manager be, and he is hereby authorized and empowered, for and on behalf of said City, to implement a Senior Citizen Nutrition Program during the remaining portion of fiscal year 1975.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and empowered, for and on behalf of said City, to execute an agreement with the SAN DIEGO UNIFIED SCHOOL DISTRICT, to operate the Senior Citizen Nutrition Program, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 748837.

BE IT FURTHER RESOLVED, that the expenditure of \$104,000 is hereby authorized out of General Purpose Revolving Fund 534 of The City of San Diego, solely and exclusively, to provide funds for the above-mentioned program.
