BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a grant agreement with the URBAN MASS TRANSPORTATION ADMINISTRATION (UMTA) in the amount of \$2,765,815 for the purchase of twenty-five (25) new 49-53 passenger buses; thirty (30) new 19-22 passenger buses; ninety-one (91) registering fareboxes; fifty-five (55) mobile transmitters; one sign truck; one 3/4-ton pickup truck; three (3) road supervisor cars; and numerous supportive equipment, furniture, and remodeling of existing shop facilities, under the terms and conditions set forth in the form of grant agreement on file in the office of the City Clerk as Document No. 748854.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$114,164 from Public Transportation Reserve Fund 2571 to Transit System Purchase 55 Buses Fund 2576 of which \$88,184 will be used as part of the local share contribution and \$25,980 to cover the one percent (1%) City sales tax requirement.
