WHEREAS, the American Television & Communications Corporation has requested a rate increase application by letter dated September 6, 1974, addressed to the Mayor and City Council; and

WHEREAS, the City Council began conducting hearings on general rate levels for cable television in San Diego on August 8, 1974; and

WHEREAS, said hearings were suspended for future investigation by the Transportation and Land Use Committee; and

WHEREAS, the City Manager and the City's rate consultant have already obtained sufficient background information and are prepared to commence a hearing on rate increase applications; and

WHEREAS, the Transportation and Land Use Committee has recommended that a hearing be commenced as soon as possible for the Rancho Bernardo franchise cable television system, said hearing to be separate from that of all other franchises in the City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That a hearing be commenced as soon as possible to determine just and reasonable rates for the Rancho Bernardo cable television system; and

BE IT FURTHER RESOLVED, that the City Manager, the City's rate consultant and the City Attorney report their findings regarding the rate study of the application of Rancho Bernardo Antenna Systems, Inc. to the Transportation and Land Use Committee; and

BE IT FURTHER RESOLVED, that the Transportation and Land Use Committee is hereby directed to commence a hearing for the Rancho Bernardo cable television system as soon as possible in accordance with the Rules and Procedures Governing Cable Television Rate Applications contained in Document No. 748858 on file in the office of the City Clerk.
