

RESOLUTION NO. 211729

WHEREAS, it is proposed that a Bicentennial Year Project to be known as "FRONTERAS 1976" be established to serve as a vehicle for expanding the knowledge and understanding of social, economic, environmental and political problems common to the United States and Mexico; and

WHEREAS, it is proposed that Fronteras 1976 be jointly sponsored by The City of San Diego and The Regents of the University of California; and

WHEREAS, Fronteras 1976 will seek to further regional and international relationships and promote future steps to realize the enormous potential of a successful program of cooperation; and

WHEREAS, as a lasting memento to the Fronteras 1976 Bicentennial Year Project, the City intends to create a permanent Fronteras secretariat for continuing coordination of local and intergovernmental relations between the United States and Mexico; and

WHEREAS, on August 19, 1974, The City of San Diego and The Regents of the University of California jointly applied to the American Revolution Bicentennial Commission of California for funding for Fronteras 1976 in the amount of \$20,000; and

WHEREAS, on September 16, 1974, The City of San Diego received a letter from the American Revolution Bicentennial Commission of California officially sponsoring Fronteras 1976; and

WHEREAS, it is desirable to formalize by agreement the joint sponsorship of Fronteras 1976 by The City of San Diego and The Regents of the University of California and to establish the City as the financial agent accountable for the receipt and expenditure of funds which may be received as a result of community participation, public subscription, and state, federal, foundation and company grants; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized to execute, for and on behalf of said City, an agreement with THE REGENTS OF THE UNIVERSITY OF CALIFORNIA, an educational institution, for the purpose of creating joint sponsorship of the Fronteras 1976 Bicentennial Year Project and establishing the City as the financial agent accountable for the receipt and expenditure of Fronteras 1976 funds, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 748945.
