RESOLUTION NO. 211752 OCT 10 1974

BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the City Manager be and he is hereby authorized and empowered to execute for and on behalf of said City, an agreement with San Diego Ecology Centre, Inc., a California nonprofit corporation, to establish and carry out a program of public environmental education, to respond to citizen inquiries referred by the City Council, to develop programs to encourage citizen involvement, and to cooperate with judicial authorities to provide misdemeanants environmental action alternatives to confinement and/or fines, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 748927.

2. That the expenditure of \$10,000 is hereby authorized out of Fund 100 of The City of San Diego, solely and exclusively for the purpose of providing funds for services to be rendered under the agreement described hereinabove.

3. That Resolution No. 208828, adopted on September 18, 1973, be and it is hereby rescinded.
