That the City Manager be and he is hereby authorized to execute, for and on behalf of said City, an agreement with the STATE OF CALIFORNIA, acting by and through the Department of Transportation, for the design and construction of traffic signals, safety lighting and conduit at the intersection of the northbound off-ramp from Interstate Route 5 with Sixth Avenue and Elm Street, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 748929.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$20,000 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for the purpose described hereinabove.
