WHEREAS, Section 21101 of the Vehicle Code of the State of California provides that local authorities may adopt rules and regulations by resolution on the matter of temporarily closing a portion of any street for celebrations, parades, local special events and other purposes when such closing is necessary for the safety and protection of persons who would use that portion of the street during the temporary closing; and

WHEREAS, it is the opinion of this City Council that it is necessary to permit sound and pedestrian/traffic testing for an Amphiplaza study test under a National Endowment of Arts grant to temporarily close PROSPECT PLACE to Coast Boulevard west and PROSPECT STREET between Girard Avenue and Herschel Avenue; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That that portion of PROSPECT PLACE to Coast Boulevard west and PROSPECT STREET between Girard Avenue and Herschel Avenue be temporarily closed from 1:00 p.m. to 5:00 p.m. on Sunday, October 20, 1974, subject to the approval of the Fire and Police Departments.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to post any and all necessary signs and barricades to effectuate said temporary closing.
