

RESOLUTION NO. 211773 R-75-739

WHEREAS, by Resolution No. 207125, adopted December 26, 1972, the City Council authorized the City Manager to submit an application to the Department of Transportation, Urban Mass Transportation Administration (UMTA) for a Federal grant under the Urban Mass Transportation Act of 1964 for the purpose of acquiring and refurbishing the Santa Fe Depot property and structure for use as a transportation and supporting commercial activity center; and

WHEREAS, UMTA has indicated their willingness to support the project subject to local, State and Federal agency review; and

WHEREAS, the California Coastal Zone Conservation Act of 1972 requires a permit application be filed whenever a development is planned that is located within 1,000 yards inland from the mean high tide line and the Santa Fe Depot is located within said area; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized to submit an application to the San Diego Coast Regional Commission for the purpose of requesting a permit under the provisions of the California Coastal Zone Conservation Act of 1972 for the acquisition and refurbishing of the Santa Fe Depot.
