BE IT RESOLVED, by the Council of The City of San Diego as follows:

Victor Comptometer Corporation are hereby accepted and the City Manager is hereby authorized to execute contracts for the OFFICE MACHINE MAINTENANCE SERVICE as may be required during the one (1) year period beginning July 1, 1974 through June 30, 1975, per prices on file in the Purchasing Department, as follows:
