WHEREAS, The City of San Diego has heretofore entered into a contract with R. E. Hazard, Inc., for the improvement of CAMINO DE LA REINA AND MISSION CENTER ROAD for work being done pursuant to the Improvement Act of 1911; and

WHEREAS, it is necessary that certain changes and modifications be made in the contract to reconcile estimated quantities with quantities used; and

WHEREAS, the net change in the contract amounts to an increase of \$481.30; and

WHEREAS, the contract price for the abovementioned project is \$487,369.90; and

WHEREAS, California Streets and Highways Code, Section 5236, provides that the Council may after construction has begun, order changes in the work of an Improvement Act of 1911 project without the necessity of further hearings so long as the amount does not exceed five percent of the amount of any original contract which exceeds \$20,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That Change Order No. 1, dated August 27, 1974, heretofore filed in the office of the City Clerk as Document No. 749224 issued in connection with the contract between The City of San Diego and R. E. Hazard, Inc., for the improvement of CAMINO DE LA REINA AND MISSION CENTER ROAD, said contract having been

filed as Document No. 745396 in the office of the City Clerk, be and the same is hereby approved; and the change therein set forth, amounting to an increase in the contract price of \$481.30, be and the same is hereby approved.
