WHEREAS, the San Diego Unified School District has deemed it fitting and necessary to place ballot Propositions XX, YY and ZZ before the voters of the City of San Diego at the forthcoming election to be held on November 5, 1974; and

WHEREAS, Proposition XX would authorize the School District to acquire sites where sites are not presently owned and lease 22 school buildings to be constructed thereon to provide for schools where the need is greatest; and


WHEREAS, Proposition YY would provide funds to help maintain, preserve and improve school property; and

WHEREAS, Proposition ZZ would increase funds needed for general educational programs in order to do more adequately the job of education demanded; and

BE IT RESOLVED, by the Council of The City of San Diego, that the voters of the City of San Diego are urged to register their approval of the aims of the propositions and to vote "Yes" on November 5, 1974.
