BE IT RESOLVED, by the Council of The City of San Diego, as follows:

and form provided by law, said warrant bearing date of this resolution, and it is further ordered to deliver said warrant, diagram and assessment to the contractor, or their assignee, as the case may be, forthwith upon payment of the incidental expenses due thereon. The City Clerk shall cause to be filed in the office of the County Recorder a copy of the assessment diagram and shall record a notice of assessment, as provided for in Section 3114 of the California Streets and Highways Code.

- 2. That the expenditure of a sum not to exceed \$15,101.45 is hereby authorized out of Gas Tax Fund No. 220, solely and exclusively, for the purpose of providing funds for the City's contribution and related expenses in connection with the improvement of STREAMVIEW DRIVE under 1911 Act Proceedings.
- 3. That the City Auditor and Comptroller be, and he is hereby authorized to transfer the sum of \$379.45 from Fund No. 244 to Gas Tax Fund No. 220, and that expenditure of said funds is hereby authorized, solely and exclusively, for the above-mentioned project.
- 4. That Resolution No. 209959 adopted February 26, 1974, be, and the same is hereby rescinded.
